#### Policy for Corporate Social Responsibility for Brødrene A & O Johansen A/S

We wish to contribute to a sustainable society across our value chain, as we see our activities as an integral part of both Nordic and international communities. We have chosen to focus our efforts on climate and environment, social conditions, and responsible governance (ESG), because as a company, we can make a positive difference ourselves and simultaneously influence our value chain towards a society where we leave a positive impact on the planet's resources and foster human progress.

Through our fundamental values—and our daily actions—we will:

- Participate in changing our value chain so that it positively contributes to our planet and the people on it.

- We take responsibility for reducing both small and large climate and environmental impacts in our own business.
- AO works actively to limit negative impacts on climate and environment in our own business
  and in the value chain with an intent to create a circular and regenerative society where we leave
  a positive impact.
- We work on reducing CO<sub>2</sub> emissions in scopes 1, 2, and 3 in accordance with the Paris Agreement through our commitment to the Science Based Targets initiative (SBTi).
- AO invests in energy-efficient solutions across our own business and works actively to promote energy and CO<sub>2</sub>-saving initiatives among our customers and suppliers.

- AO has zero tolerance for harassment and discrimination. No AO employee, customer, supplier, or others associated with our company should be subjected to offensive or discriminatory behaviour.
- We support equality as a natural part of our approach to all people.
- AO safeguards the right to privacy and focuses on compliance with our data ethics rules.
- We consider diversity and gender diversity natural and important both humanly and as a way to create a competitive company with the most skilled employees.

### Governance
